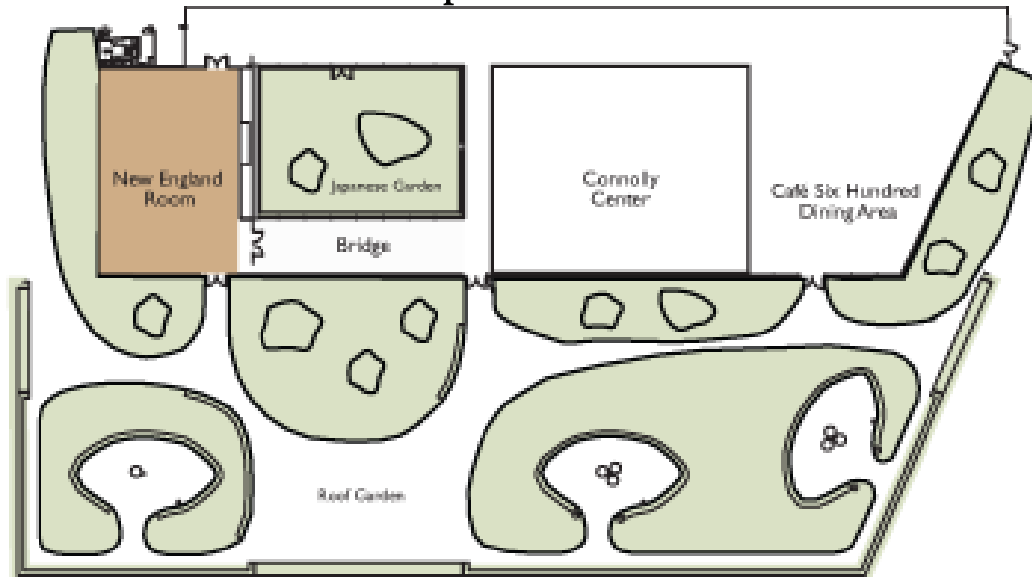
Afternoon Tracks:
